



Riotous Youth Company Summer 2017 GENERAL INFORMATION

August 7-August 25, 2017: Monday-Friday, 9:00AM - 3:00PM

THE PROGRAM

This program is designed to provide an opportunity for young actors to take the next step in their training. Actors who are heading into 9th-12th grade who have participated in Riotous Youth for at least two sessions, or have equivalent experience in other Shakespeare & Company Education Programs, are eligible to apply. Classes may include: ensemble building, voice, movement, clown, fight, and acting. At the end of the three weeks they will perform scenes chosen specifically for them from a number of Shakespeare's plays.

TRANSPORTATION

Students should be dropped off each morning between 8:45 and 8:55 AM and should be picked up promptly at 3:00 PM.

LUNCH/SNACKS

We will take breaks each day and break for lunch at approximately 12 PM. Students must bring a lunch, a snack and something to drink; refreshments will not be available for purchase. A celebratory pizza lunch will be provided on the second Friday for any who wish to participate.

COST

Tuition is \$675 per student

Tuition includes three weeks enrollment, a Riotous Youth Company 2017 T-shirt, and pizza on "Pizza Day."
(Please remember to specify a T-shirt size or we will order an adult small for your child).

Sibling Discount: \$30 off for the second sibling, \$50 off for the third, \$75 off for the fourth.

Multiple Session Discount: \$30 off for the 2nd session, \$50 off for the 3rd session,

ENROLLMENT

Eligible applicants will be accepted on a space available basis. Space is limited. Please complete the application form and send it with full tuition payment or a minimum deposit of \$300 per student to: Education Program, Riotous Youth, Shakespeare & Company, 70 Kemble St., Lenox, MA 01240 **Students are not considered enrolled in the program unless a completed form and the full tuition are received (enrollment cannot be processed over the phone).**

REFUND POLICY

Total refund, minus a \$50 application fee per child, is available if participant notifies Shakespeare & Company in writing more than **six full weeks** before the start date of the session. A 50% refund (minus a \$50 application fee per child per session) is available if participant notifies Shakespeare & Company in writing more than **four full weeks** before the start date of the session. Any change in enrollment (i.e. switching sessions) is subject to an additional \$50 application fee. *No refunds will be given within four full weeks of the start date of the program.*
